## SERVICE OFFICER REPORT

Hello and Merry Christmas and Happy New Year to all! I hope everyone had a great Holiday Season. I found out that there are going to be increases in VA awards to certain Vietnam Veterans that were exposed to Agent Orange. Please see the article below for additional information.

VA Set to Approve New Agent Orange Benefits. 12/18/09 - NAUS has learned that a new ruling as a result of a San Francisco court decision related to the Nehmer court case decision will lead to a 20% increase in VA awards for those who served in Vietnam and were exposed to Agent Orange with presumed service connected disabilities.

NAUS, whose President, Bill Matz, MG, USA (Ret), is a decorated (DSC and Purple Heart) Vietnam veteran, applauds VA Secretary Eric Shinseki's decision to expand Agent Orange benefits to an estimated additional 185,000 Vietnam Veterans and their widows.

The VA is expected to officially announce the new regulations by early 2010. In order to assist with claims backlog and new exams, the VA will accept letters from family physicians supporting claims for Agent Orange related conditions. Thousands of widows whose husbands died of Agent Orange disabilities will benefit from retroactive benefits and back pay, as well as DIC payments. About 86,000 claims previously denied by the VA before 1985 will be revisited. The VA expects to pay nearly \$50 billion in additional

benefits due to these long overdue changes in Agent Orange exposure related conditions, with \$14 billion expected to be paid related to heart disease alone.

Both the Veterans Benefits Administration and Veterans Health Administration expect to be deluged by an increase in new claims. NAUS encourages its members and potential new members to contact the NAUS staff, assisted by NAUS board member Win Reither, Col, USAF (Ret), to stay tuned for updates, as well as progress reports of the VA claims handling.

Please note that we have a dedicated group of members who are willing to honor your loved one at his / her funeral. However, if we do not know your loved one has passed into the arms of the Great Commander, we cannot give this honor to him / her. If you wish to be called to be part of the "honor team" please let me know.
